On the 26th - 27th September 2002, the Japan Research Council workshop took place at Hitotsubashi Memorial Hall, Kanda, Tokyo. Reporters were: Professors Y. Hirano (Nihon Univ.), Y. Sasajima (Meiji Gakuin Univ.), A. Imafuku (Nihon Univ.), Mr. T. Totsuka (Japan Pension Navigator), Ms. R. Fukuda (Matsushita Electric Industrial Co., Ltd.) and Prof. J. Piggott (Univ. of New South Wales). Detailed reports were given on tax systems, employee compensation/benefit packages, accounting, the contracting-out, the case of Panasonic, and the Australian Pension System. Political Aspects

A symposium on politics of intergenerational equity was held on the 18th November 2002 at Gakushi Kaikan, Jinbocho, Tokyo. Reports by Professors A. Tanaka (Waseda Univ.) and K. Tanabe (Univ. of Tokyo) were followed by lively disucssions with the audiences. Then, with Prof. S. Kitaoka as the chairman, Prof. J. lio (National Graduate Institute for Policy Studies) put forward questions which were discussed by Mr. N. Akagi (MP, LDP, and Deputy Director of the Defense Agency), Mr. T. Itoh (MP, LDP, and Vice Minister of Cabinet Office), Mr. Y. Noda (MP, DPJ). Opinions were exchanged on the subject of intergenerational equity within the political arena, and further, ways of overcoming the intrinsic intergenerational inequity among the voters were seriously debated.



International Workshop on Declining Fertility

Declining Fertility

On the 20th - 21st November 2002, an international workshop on "declining fertility and social policy" took place at the ADB Institute, Kasumigaseki, Tokyo. The workshop aimed to compare similarities and differences of developed countries which face declining fertility like Japan. These countries were classified by language and area (German, English, French, Japan, Scandinavia and South Europe) and the respective birthrates and family policies were compared/contrasted. In the discussion which included 6 invited guests from abroad, it was agreed that supporting working parents and financial aid to child rearing are of vital importance. Also it was concluded that companies must change their workplace policy to "family-friendly" and further the formation of a gender-equal society must be promoted. All reports given at the seminar will be revised and included in PIE DP series.
