Intergenerational Equity and Principles of Cost-sharing

An international symposium on "intergenerational equity and principles of cost-sharing in the context of globalwarming" was held on the 8th-9th March, 2003 at the National Center of Sciences, Tokyo. Opened with the keynote address by Prof. K. Suzumura (Hitotsubashi Univ.), the symposium had nine distinguished reporters: Professors K. Basu (Cornell Univ.), Y. Xu (Georgia State Univ.), T. Shinozuka (Otaru Univ. of Commerce), K. Suga (Waseda Univ.), K. Tadenuma, C. Hara, S. Morimura and N. Yoshihara (all from Hitotsubashi Univ.); and Dr. R. Gotoh (National Institute of Population and Social Security Research). The approaches by the reporters ranged from social choice theory to economic ethics, further to legal philosophy. Valuable comments were given by guest participants including Professors K. Kawamata (Keio Univ.), and T. Kishimoto (Kobe Univ.). Experts from various disciplines made this international symposium a memorable academic event, cutting deep into the topic of intergenerational equity.

Release of a New Research Monograph

As part of our PIE Project, papers submitted to several PIE sponsored international seminars/workshops on pensions have been complied into the volume **Taste of Pie: Searching for Better Pension Provisions in Developed Countries,** released in March 2003 by Maruzen Co., Ltd. The Future of Corporate Pensions

On the 15th April 2003, the seminar on The Future of Corporate Pensions in the United States and Japan was held at Hitotsubashi Memorial Hall, National Center of Sciences, Tokyo, co-hosted by PIE, the Asian Foundation and the German Institute for Japanese Studies. Dr. W.D. Crist, former President of the Board of Administration of CalPERS gave a keynote speech on the corporate pensions of the US, followed by reports from Mr. T. Yano (Executive Managing Director of Japanese Pension Fund Association) on Japanese corporate pensions, and Dr. F. S. Wiebe (the Asia Foundation) on corporate governance. A thorough debate mainly focused on the relationship between pension funds and corporate governance took place.
