

## Globalization of Japanese Labor Market

The book provides a guideline for enlivening debates, and discusses the foreign labor issues in the following 3 perspectives.

First, the book historically reviews foreign labor issues, analyzing the supply/demand adjustment mechanism in the global labor market.

Second, the book clarifies how much current Japanese labor market globalized through detailed investigation into the practice of labor/employment.

Third, the book considers the debate on Japanese society and foreign labor policy.

This book further examines the future of foreign labor policy, taking into account the future of Japanese economy, demographic changes and immigration, and intergenerational conflicts within the family of foreign laborers.
